Woodland Canines Health Guarantee

| Condition Of Sale |

Your puppy is guaranteed to be in good health at the time of sale. The purchaser receives a **seven day** incubation health benefit. If the puppy requires veterinary care during this period, the breeder's responsibility is limited to health concerns proven to be incubating prior to the puppy leaving Woodland Canines. Compensation is considered only when breeder approved veterinary sources are used, regardless of the distance the puppy has traveled.

This guarantee does not include **coccidiosis**, **giardia**, or **acquired intestinal parasites**. Puppies receive extensive preventative care for these conditions, yet follow up treatment may occasionally be needed. In such cases, only the reasonable cost of medications may be provided or reimbursed.

Any request for compensation must include an official veterinary report confirming that the condition was incubating before the puppy was taken home. Regular, emergency, or after hours veterinary fees are not guaranteed for reimbursement. These decisions remain at the sole discretion of the breeder. Exorbitant diagnostic or treatment fees are are not promised to be compensated and such remains solely at the discretion of the breeder.

Your puppy carries a **two year limited warranty** for **congenital life threatening conditions** that would result in death. Replacement of the puppy may be offered. **No cash refunds are given**. All situations are reviewed and considered individually.

The purchaser understands the needs of this breed, including nutrition, exercise, and general care requirements.

Woodland Canines Purchase Agreement

All requests for compensation must include a complete veterinary report. The breeder, Darral Schwartz, may request that the puppy be examined by a veterinarian of his choice, at his expense, regardless of distance. If the buyer fails to comply with this request within a reasonable time frame, the breeder may deny compensation.

The breeder assumes no responsibility for the puppy once it has left the premises for reasons such as landlord approval, allergies, family disagreements, or any circumstance not covered under the condition of sale. The breeder is not responsible for parasites such as fleas, ticks, or intestinal parasites after the puppy has left Woodland Canines.

Vaccine Schedule

Your puppy is current, but not complete, on vaccinations. Please limit exposure to other pets, public places, and unfamiliar environments until your veterinarian completes the vaccination schedule.

Limitations of Warranty

The breeder's responsibility is limited to incubating and congenital conditions only. Accidents, injuries, improper feeding, accidental intake, panic related incidents, or failure to follow the breeder's care instructions are not covered. Purchaser agrees that any legal action for compensation must take place in the county of sale.

The breeder does not guarantee this puppy for breeding purposes. The purchaser is solely responsible for all future veterinary care, health care, feeding, socialization, training, grooming, shelter, safety, and overall well being.

The purchaser understands the need for a qualified and dependable veterinary support system.

Care and Adjustment Period

Remember that your new puppy is still very young. Puppies need proper rest, fresh water, a comfortable place to sleep, gentle exercise, affection, and the diet explained to you at pickup. Please allow your puppy to sleep without frequent disturbances.

Some puppies may experience a short adjustment period in their new home. Temporary sadness or a reduced appetite can be normal. If anything concerns you, please contact us.

Your new puppy is the beginning of a happy and special chapter in your life. Take plenty of pictures, enjoy the journey, and love your new companion. Woodland Canines is here to support you whenever you have questions.
